

Eligibility

All VBH Group Homes are licensed by the Ohio Department of Jobs and Family Services for placement of youth 10-21 years of age. Individuals accepted into the program will need to match the demographics of the other residents of the home regarding age range, sex, level of functioning and severity of behavioral issues.

Group Home Services are intended as a step down program from a treatment facility, a DYS facility, or as part of the continuum of service for youth who are not successful in Foster Care. Individuals are expected to have significant barriers that require treatment, target behaviors that need eliminated, as well as requiring assistance in developing skills that have prevented the individual's independence.

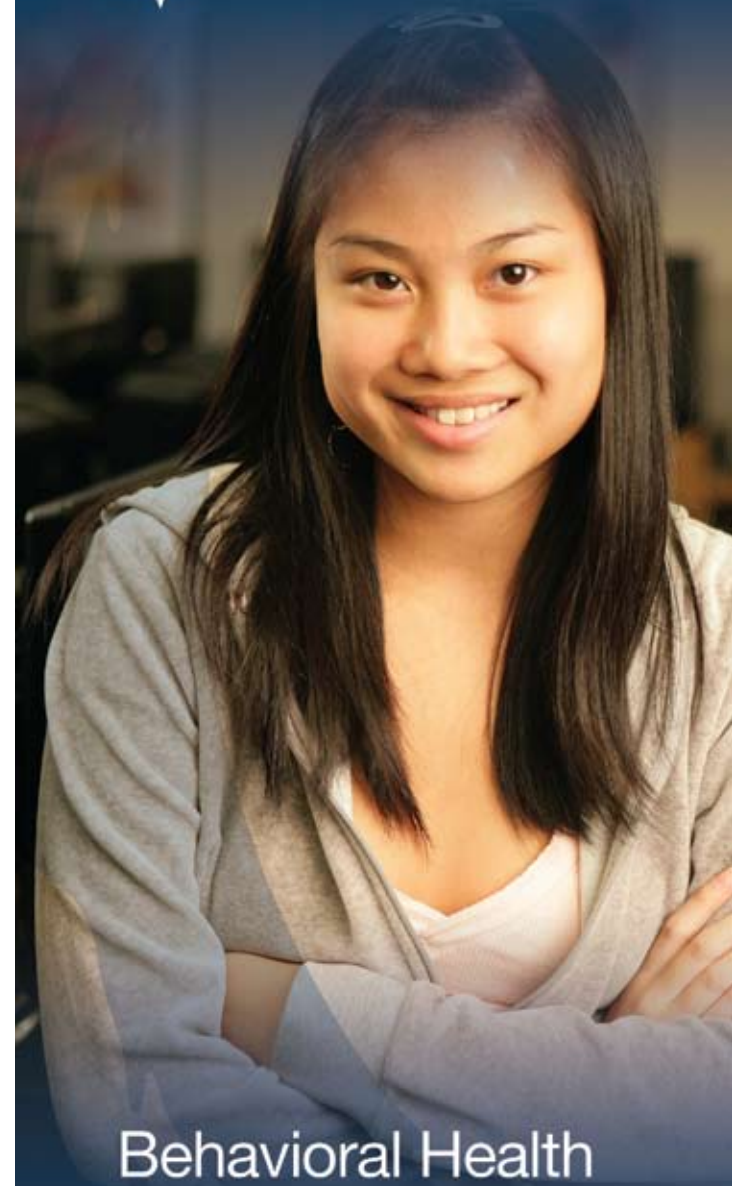

Residential Services

ViaQuest Behavioral Health (VBH) offers IV-E eligible, staff-secure residential homes that range in size from 3 to 6 beds. Our group homes are specifically designed to assist both young males and females with behavioral challenges, those with developmental disabilities, and/or mental health concerns, including a history of sexual victimization. The goal of our program is to assist individuals in modifying their behavior, so they are able to reside in a less restrictive environment.

ViaQuest Behavioral Health Group Homes Provide:

- The ability to serve ages 10-21
- Minimum staff to youth ratio of 1:3
- Psychiatric and Medication Management Services
- Nursing services are available
- Mental Health Treatment
- Staff certified in Delegated Nursing training to assist in medication management and administration
- Case management services to include coordination with Probation/Parole, AoD Services, Sex Offender Services, Vocational Services
- Linkage to day habilitation and vocational programming

- Linkage to specialized services as indicated (offender treatment, speech services, occupational therapy, etc)
- Transportation to appointments
- Individualized Level System – specific to unique target behaviors
- Casey Life Skill Assessment and Skill Development – money management, cooking, etc.
- Weekly Recreational Schedule



Program Oversight

- We provide an intensive tri-level quality assurance process completed by Support Service Coordinators, Program Directors and our full time Quality Assurance Specialist.
- In addition to monthly staff meetings, VBH holds quarterly, all-staff meetings to provide specific training on policies, procedures, and regulations, as well as continuing education on developmental disabilities, mental health, sex offenders, behaviors, documentation and more.
- Treatment outcomes measured via the OACCA Outcomes Data Project
- ViaQuest is CARF accredited and ODMH certified to provide treatment services. Our masters level clinicians offer full diagnostic assessment, personalized individual and group therapy, and case management for individuals with mental health needs.
- Skill Development measured via the Casey Life Skills Assessment
- Incident Report analysis tracking and measuring of target behaviors
